Blueprint and its content

- ❑ The blueprint is a detailed description of non-state pension system part and funded component of insurance – pension system for design which includes all aspects of operation for each part – entitlements, organization, administration, performance, financing, reporting, monitoring, controlling, supervision and based on blueprints, this description itself will be transformed into articles of law and/or other legislative rules.
- ❑ In the end of activities 1.2. and 3.1., experts will prepare – a detailed blueprint of the funded system and blueprint providing a detailed description of market for private, voluntary, pension arrangements – according twinning project contract).
