Augulis



Steinar Egil Hagen has been the Norwegian Ambassador to Latvia since September 2014. Before arriving in Riga Ambassador Hagen was Head of the Section for Central Europe and the EEA Financial mechanisms in the Norwegian Ministry of Foreign Affairs in Oslo.



Jiří Švarc is responsible for the implementation of the European Social Fund and the Fund for European Aid to the Most Deprived in Hungary, Finland, Lithuania, Estonia, Latvia. His unit also analyses the employment and social inclusion policies in the countries mentioned, particularly within the framework of the Europe 2020 strategy. Before joining the Commission he worked for the Czech Ministry of Industry and Trade and the Ministry of Finance on European affairs.



Jan Jařab has been the Regional Representative for Europe of the UN High Commissioner for Human Rights since January 2010. The Regional Office for Europe deals with the human rights dimension of internal and external EU policies as well as with human rights challenges in EU Member States and Candidate Countries. Previously, Jan Jařab served as Member of Cabinet of Vladimír Špidla, European Commissioner for Employment, Social Affairs and Equal Opportunities (2004-2010). For almost four years (2001-2004) he served the Government of the Czech Republic as its Commissioner for Human Rights and Director of the Human Rights Division of the Office of Government. Before that, he worked for the Human Rights Division for two years (1991-2001) as Secretary of Section on Civil and Political Rights and Section on Racial Discrimination. Jan Jařab holds a doctorate in

medicine from Prague's Charles University and a MSc in anthropology from University College London.

Uldis Augulis is Minister of Welfare of the Republic of Latvia (Centre Party "Latvian Farmers Union" / Union of Greens and Farmers), and his responsibilities include policies on social protection, employment, labour law, family and children's rights, equal opportunities for persons with disabilities and gender equality. Mr Augulis started his political career as Chairman of Berze Rural District Council (2000 - 2006), when he was also Member of the EU Committee of the Regions (2003 -2006). After parliamentary elections of 2006, Mr Augulis became Member of the Saeima (Parliament) of the Republic of Latvia and served as Parliamentary Secretary of the Ministry of Agriculture (2006 – 2007) and Parliamentary Secretary of the Ministry of Welfare (2008 – 2009). In 2009, Mr Augulis was appointed Minister of Welfare, later - Minister of Transport (2010 - 2011). After parliamentary elections of 2014, he was re-appointed Minister of Welfare.

Since 2008, she is Advisor in the Disability Rights Fund collaboration between donors and the disability community to advance the new UN Convention on the Rights of Persons with Disabilities (CRPD). John Halloran is the Chief Executive of the European Social Network (ESN), a learning organisation which brings together directors of social care and health services in national, regional and local government responsible for the design and delivery of local public services in 34 countries. Supported by the European Commission, ESN promotes social justice and inclusion and better life chances through the delivery of quality social services. John was previously a senior manager of public welfare services in the UK where he was responsible for community services for the elderly, people with physical and intellectual disabilities and family and child protection services. He worked as a manager of youth services in France, as a volunteer teacher in West Africa and as a change management consultant for public authorities and third sector organisations in a number of countries. He studied philosophy at the Université des Sciences Humaines in Strasbourg, social work at Manchester and Lancaster Universities and has an international Masters in Business Administration from Brunel University, London."

Iris Arends has a background in Work and Organisation Psychology. She completed her PhD in the field of Work and Mental Health in 2013, and since then she has been working for the Organisation for Economic Cooperation and Development (OECD) at the Directorate for Employment, Labour and Social Affairs. She works within the review team on Mental Health and Work and is one of the authors of several country review reports and the recently released synthesis report "Fit Mind, Fit Job".

Michelle lives in the North West of England and is a consultant and trainer as well as operational manager for Helen Sanderson Associates. Michelle has been involved in the development of person-centred practices across a wide range of service areas including health, social care and education and has contributed to several publications on the subject. Michelle is passionate about cultural change, community building and being a member of a local darts and dominoes team.

For more than two decades, Georgette has worked in 23 countries around the world, leading large-scale programmes to transform the lives of thousands of disadvantaged children. She pioneered a model of 'deinstitutionalisation' (DI) now followed by many governments, preventing the separation of children from families, returning children from so-called 'orphanages' to families, and shifting finances from harmful institutions to community services that support children in families. She advises officials at the European Commission on using EU funds for reforming children's services, and has published four books on children's rights. Georgette is a Commissioner for the UKbased Commission on Civil Society and Democratic Engagement. In 2014, she was named as 'one of the world's 30 most influential social workers' by socialworkdegreeguide.com. She is Chief Executive of Lumos, an international children's organisation, founded by J.K. Rowling to end the institutionalisation of children globally by 2050.

Anniki Lai, MA (1974) is a policy maker in the area of child welfare who integrates evidence-base tools and services, comprehensive policy and organisation development as well as system design approaches into creating innovative child welfare systems. During her long career in the Ministry of Social Affairs, Estonia, she initiated creation of a dedicated department oriented for children and family policy, led development of the first integrated national strategy on children and families that provides intersectoral vision for the field and spearheaded modernisation of national legislation for ensuring children well-being. Currently she is leading organisational restructuring and development of child protection system to implement the vision of the national strategy and the modernised legislation. In her ministerial work she has been able to use her extensive experiences from her previous work in NGO level in promoting children rights. She has also been actively engaged in various international working groups and organisations in the field of child rights. Examples include being current chair of the Expert Group for Cooperation on Children at Risk in the Baltic Sea Region, active participant in the EU and COE child rights network as well as activities in her capacity as an international expert on

integrated child protection systems.

Born in Prague on 22 of Jun 1957 Jan Pfeiffer finished his medical study on Charles University Prague in 1982. He has more then 30 years of clinical experience in mental health care. He is in his clinical practice oriented mainly on people with serious psychosocial issues and their recovery. He was practicing in Czech Republic as well in United Kingdom. During his entire professional carrier he is very much involved in transformation of institutional services to community based services (deinstitutionalization) in his country as well other countries (Albania, Serbia, Slovakia, Hungary....). Working as long term consultant, advisor or expert for many international bodies as (WHO,

advisor or expert for many international bodies as (WHO, European Commission, CPT Committee Council of Europe, Global Initiative on Psychiatry, Higher Commissioner of Human Rights of United Nations, Lumos foundation of J.K.Rowling). He was first Chair of European Expert Group on "DI" (EEG), is also Senior Consultant of Mental Health Europe with a focus on DI in mental health.

For his involvement in reforming institutional services and protection of the rights of people with disability Magazine Time awarded him as European Hero in 2004.

Peter Lambreghts was born in Antwerp, Belgium in 1971. He is happily married and father of two daughters.

Currently Peter combines two jobs. He is Policy Officer and Spokesman for Onafhankelijk Leven, the Flemish movement for Independent Living and works as Senior Officer for ENIL, the European Network on Independent Living. He also is a Board Member for ENIL and for EDF, the European Disability Forum. Furthermore he is member of the European Expert Group on Deinstitutionalization. Peter Lambreghts is author of several publications on disability related topics including quality control of disability support services, cost effectiveness of Personal Assistance, the UNCRPD & article 19, Independent Living philosophy and history, disability paradigms, Quality of Life. He is regularly interviewed and writes articles for newspapers, magazines, newsletters and specialized journals. He is often asked as speaker for lectures. workshops and trainings. In his work Peter wants to continue to promote and strengthen the grass roots and cross-disability Independent Living Movement and keep the right for Independent Living high on the agenda in Europe and the member states. He also wants to focus on implementation of the UNCRPD and countering the effect of

Luk Zelderloo has been professionally active in the disability sector for more than 22 years. He holds a Master's degree in Management, Social science & philosophy. For more than 13 years he was active as manager of a social service for persons with disabilities in Flanders. For the last 15 years, he has been active at the European level. Alex Dressler is the consultancy manager of Keeping Children Safe, a UK-based coalition formed in 2001 by some of the leading international development agencies to protect children from harm. Alex has 22 years' experience in international development in more than 30 countries. He has been the CEO of the Consortium for Street Children; a regional delegate for the Federation of Red Cross and Red Crescent Societies, where he developed a participatory community development programme in support of vulnerable Roma communities in Central and Eastern Europe; and as an organisation development consultant, he helped the Russian Association of Social Pedagogues and Social Workers to make the transition into a post-Communist era organisation. He also spent four years helping to transform a group of Romanian volunteers into the country's leading HIV/AIDS prevention network. Alex is the proud father of four children, including a little boy who was born with Down Syndrome.

Jan Storø is an Associate Professor at Oslo and Akerhus University College, Faculty of Social Sciences, School of Social Work. He has more than 30 years of practical experience from child welfare work in Norway, mostly with young people in residential care

Storø's main professional interest for the last two decades has been leaving care issues. He has published three books and several articles on this topic. He has also conducted a study on care leavers in Norway, and continues to research this topic further. Other areas of work; organising and managing institutions, evidence based practice, user participation and child welfare work in modern society. He has written several articles on these topics. Two of his books are on Social pedagogy.

Galina Markova, is the manager of the Know How Centre for Alternative Care for Children at the New Bulgarian University. She gained her PhD from Smith College School for Social Work (USA) and her MASW from the New Bulgarian University. For her dissertation she studied the psychological factors contributing to child institutionalization in Bulgaria by their biological parents. She teaches theories and practice in social work, supervises and does research mostly in the field of deinstitutionalization of children's services. She has published nationally and internationally. She has been the national consultant to DI for the Childhood for all projects - DI of children with disability. Her latest work is in the field of the strength-based perspective in research and practice.

Nic Crosby has worked with many services, families, children and young people across the united Kingdom over the past 9 years to develop personal budgets. He champions inclusion and the rights of families and young people to have control over the support they need. he has worked closely with the national government to develop new policy for families and disabled young people and is involved in the ongoing implementation of personal budgets. he has written extensively about how personal budgets work, how they can make a profound difference to families' lives and the lives of their children and young people and how personal budgets offer a real opportunity for children and young people to get the support they need to have a life like many others.


